TERMS AND CONDITIONS

- **CONTRACT PERIOD** June 1, 2010 thru May 31, 2011
- **AGREEMENT** This is a binding contract. A new contract must be filled out every year, even if you are rolling over unused dollars from the previous year. Heating oil will be delivered to the address below by Aabbot's or Mauger trucks only.
- **AUTOMATIC DELIVERY** All budget or prepay customers must be automatic delivery customers. ALL new automatic delivery customers must call to schedule their first three deliveries. Please call when tank gauge is 1/4 full.
- All deliveries after June 1, 2010 will be charged against your contract gallons. Gallons used for the contract period that exceed your original price-protected gallons are charged at our current retail price at time of delivery.
- **You will remain on automatic delivery unless you notify us in writing, even if all of your contracted gallons have been used.**
- **SALES TAX** PA sales tax will be charged against your prepay dollars unless you are exempt.
- **BUDGET PLAN PAYMENTS** Due by the 10th of each month. Prompt, on-time payments will keep your account from being placed on "delivery hold".
- **ALL ABOVE GROUND TANKS ADD \$7.50 PER DELIVERY** SOS, a special additive formula designed to help eliminate moisture/condensation and is an oil anti-gel.
- **MINIMUM DELIVERY 150 gallons, regardless of remaining pre-pay/budget gallons.**
- **UNUSED DOLLARS** Unused pre-paid dollars will not be refunded until after September 10, 2011, or the dollars may be rolled into the next year's plan at the following year's price per gallon.
- **DISCLAIMER** Prices are guaranteed for contracted gallons from June 1, 2010 to May 31, 2011 unless we experience supply disruptions due to acts of God, foreign or domestic governments, or major oil companies.
- **REQUESTS FOR CHANGE** All requests to change your contract must be submitted to MAUGER in writing; no exceptions. Your request is subject to MAUGER'S approval.
